## Como Station Upgrade

### COMMUNITY NOTIFICATION

June 2019

Como Station will be upgraded as part of the Transport Access Program, which aims to provide a better experience for customers by delivering accessible, modern, secure and integrated public transport infrastructure.

Subject to further consultation with key stakeholders, Como Station upgrade scope would include two new lifts, relocated accessible parking spaces closer to lifts, plus upgraded station entries from the commuter car park and the ramp from Railway Road and formalised kiss and ride area.

### Project update

Planning approval was granted earlier this month and preliminary design work is now underway on the Como Station Upgrade. In order to progress the design, a suite of on-site investigative works are being undertaken by Laing O'Rourke. These site investigation works are currently expected to take no more than three months to complete.

### Weekday site investigations from 28 June to 26 July 2019

**For up to two weeks between Friday 28 June and 26 July, site investigation activities will occur during normal working hours of Monday to Friday from 7am to 6pm.** This work will include underground services investigation, surveying and station building condition inspections. The investigative work will occur on the station platform, Como Parade station entry and car park.

Equipment will include surveying equipment and hand tools. This work will not be noisy.

To facilitate the site investigations, **a small temporary site plant and material laydown area will be set up inside the rail corridor off Como Parade from Friday 28 June.** Upon completion of these investigation works, the site compound will be removed.

### Weekend investigative work on 29 and 30 June 2019

**Site investigations, including drilling a borehole, are scheduled to occur during the scheduled Sydney Trains trackwork weekend of 29-30 June 2019, between 7am to 5pm Saturday and 8am to 5pm Sunday.** Additional equipment will include a vacuum truck, small drilling rig and elevated work platform. This investigation work will occur within the rail corridor, on the station platforms, Como Parade Car Park, Como Parade station entry and Railway Road station entry.

There will be temporary loss of up to five parking spaces in the Como Parade car park. Signage will be in place to advise car park users and pedestrians.

Work has been planned during the scheduled trackwork weekend when no trains will be running, to improve the safety of workers and minimise impact on the community. ## Community Feedback

Thank you to the community for providing feedback on the Review of Environmental Factors (REF) for Como Station upgrade during the public consultation period in April 2019. The project has since been granted planning approval and a Determination Report was developed to identify how feedback has been addressed and conditions of approval.

Key feedback that emerged from the REF consultation included:

- General support for Como Station becoming accessible
- Request to maintain the ramp access from Como Parade
- Suggestions of sustainability initiatives to implement in the design
- Requests for provision of a kiss and ride facility on Como Parade
- Request to retain as much vegetation as possible to maintain the look and feel of the station.
