Clarendon Station Upgrade

Community Notification – May/June 2022

Project overview

Planning approval has been granted for an accessibility upgrade at Clarendon Station as part of the NSW Government's Transport Access Program. Transport for NSW is upgrading Clarendon Station to make it easier for everyone to access public transport, including people with a disability or limited mobility, parents/carers with prams and customers with luggage.

Key features of the upgrade will include:

- two new accessible parking spaces on Racecourse Road
- upgrades to station footpaths, ramps and platforms, including new tactiles
- new seating with widened platform at the Boarding Assistance Zones
- modifications to existing waiting areas to improve accessibility
- a new family accessible toilet and an upgraded ambulant toilet
- new bicycle hoops
- improvements to CCTV, lighting and wayfinding

Upcoming work and site set up

Site set up and construction activities will start from mid May 2022 and will include:

- delivery and installation of temporary fencing and site sheds
- connection of temporary utility services
- excavation around the platforms and station buildings
- demolition work in the toilet building and permanent removal of Telstra payphone on Platform 2
- concrete work near the toilet building and along the platform.

Equipment to be used includes generators, excavators, rollers, trucks, concrete pumps, jack hammers and hand tools.

Construction hours

Standard construction hours are **7am to 6pm Monday to Friday and 8am to 1pm on Saturdays.** Work will not be carried out during the Hawkesbury Show from Friday 6 May to Sunday 8 May 2022 and pedestrian access will be maintained at all times.

For the safety of staff, customers and the community, some work will be completed outside standard construction hours. We will notify nearby residents and businesses in advance if we need to work outside these times.
