and Restatement — Tunnel Support



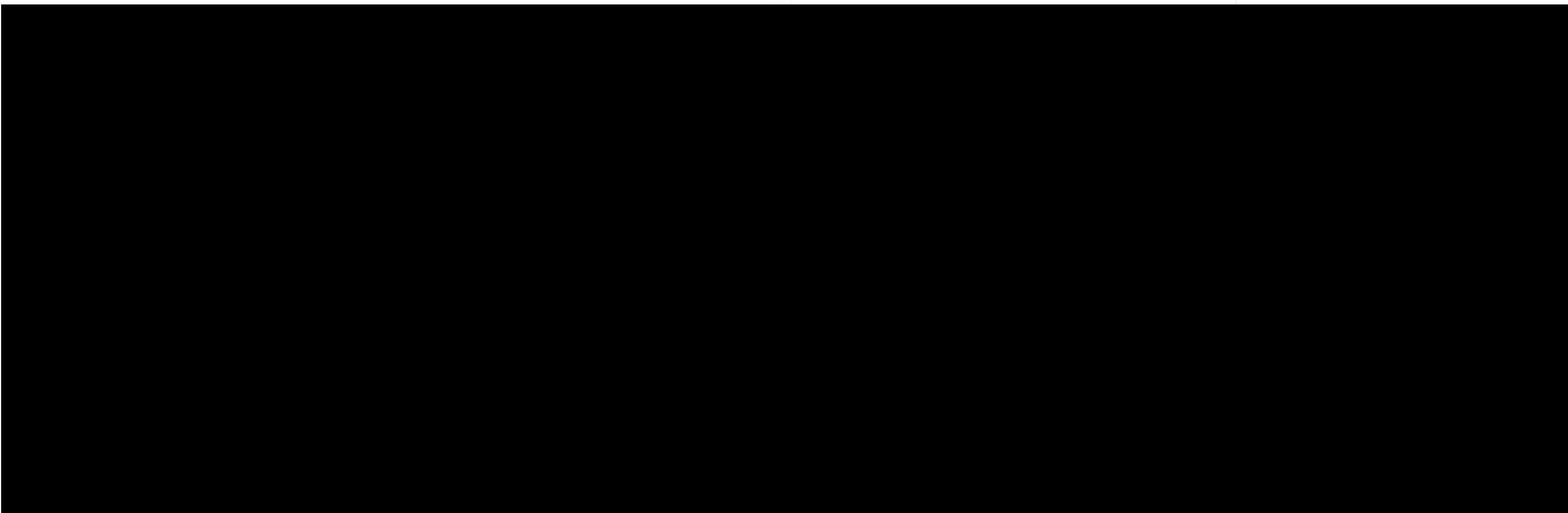
